Applications are invited for empanelment of following Faculty (Regular/Contract) posts on the prescribed application form so as to reach the office of the Registrar latest by **July 4, 2016.**

Application form as well as Academic Performance Indicator (API) and Performance Based Appraisal System (PBAS) Proforma are available at the University Website: www.davuniversity.org. Candidates are required to submit the downloaded application form, duly filled in all respects along with the cost of application form through a crossed A/c Payee Bank Draft of **Rs. 1000/- (Rs. 500/- for Handicapped Persons & SC/ST category Candidates)** in favour of the “**REGISTRAR, DAV UNIVERSITY, JALANDHAR**” payable at Jalandhar.

- Those who have applied earlier against the University advertisements appearing on Nov 12, 2015 & January 13, 2016 need not apply again as their earlier applications would be considered. However, in case they have any additional information/ documents to submit, they may do so by submitting the details thereof to vc@davuniversity.org.
- Merely applying does not give an applicant a right to be called for interview.

EMPANELMENT OF FACULTY (REGULAR/CONTRACT)

(A) FACULTY : Professor/Associate Professor/Assistant Professor

Essential Qualification:

The minimum qualifications required for the post of Professor, Associate Professor and Assistant Professor are as per the UGC norms which are as under:

PROFESSOR

- a) An eminent scholar with Ph.D. qualification(s) in the concerned/allied/relevant discipline and published work of high quality actively engaged in research with evidence of published work with a minimum of 10 publications as books and/or research/policy papers.
- b) A minimum of ten years of teaching experience in university/college, and/or experience in research at the University/National level institutions/ industries, including experience of guiding candidates for research at doctoral level.
- c) Contribution to educational innovation, design of new curricula and courses, and technology – mediated teaching learning process.
- d) A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS).

OR

An outstanding professional, with an exceptional accomplishment established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned/allied/relevant discipline, to be substantiated by credentials.

ASSOCIATE PROFESSOR

- a) Good academic record with a Ph.D. Degree in the concerned/allied/ relevant disciplines.
- b) A Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed).
- c) A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry excluding the period of Ph.D. research with evidence of published work and a minimum of 5 publications as books and/or research/policy papers.

- d) Contribution to educational innovation, design of new curricula and courses, and technology – mediated teaching learning process with evidence of having guided doctoral candidates and research students, as evidenced by Ph.D. thesis/co-authored books/publications in peer reviewed journals.
- e) A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS).

ASSISTANT PROFESSOR

- a) Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- b) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR.
- c) Notwithstanding anything contained in (b) above candidates, who are, or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET.
- d) NET shall also not be required for such Masters Programmes in disciplines for which NET is not conducted.
- e) A relaxation of 5% may be provided, from 55% to 50% of the marks to the Ph.D. degree holders, who have passed their Master's degree prior to 19th September, 1991.
- f) Relevant grade which is regarded as equivalent of 55% wherever the grading system is followed by a recognized university shall also be considered eligible.

TRAINING & PLACEMENT OFFICER

- First Class or equivalent Engineering/ Science Graduates with MBA from an Indian University or an equivalent degree from an accredited foreign university.
- The applicant must have a proven experience of 5 years or more, having conducted training and placement activities for a reputed academic/ technical institute.
- Must possess excellent oral and written communication skills.

In case of any controversy on any point/issue demanding clarification, the guidelines of the UGC will be applicable.

NOTE:

1. Qualifications, pay scales & other conditions etc. can be changed by the Management, if so desires. Number of posts will be decided and filled by the Management depending upon the requirement. The Management also holds the right not to fill any of the posts advertised.
2. Retired persons can also be considered for service on contract basis with salary as per rules :

Last Pay drawn (Basic Pay + GP) minus full applicable Basic Pension (i.e. half of Basic Pay drawn) (a)

Plus DA applicable on (a) above.

Plus applicable allowances on (a) above.

OR

Total salary of the post minus Full basic pension

OR

As settled at the time of appointment.

3. Separate applications along with the requisite fee in the form of Demand Drafts are required for each post.
4. In case of large number of applicants, the University may hold written, qualifying test/group discussion.
5. Incomplete applications will not be entertained.

Shortlisting of Applications:

- a) The prescribed qualification and experience will be minimum, and the mere fact that a candidate possessing the same will not entitle him/her to be called for interview.

- b) The University will have the right to restrict the number of candidates to be called for interview, based on the recommendations of the Screening Committee constituted as per the Regulations for this purpose, to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed or by any other condition that it may deem fit.
- c) Candidate applying from abroad may send their application through e-mail to the jobs@davuniversity.org latest by prescribed date, i.e. **July 4, 2016**. - d) The Scrutiny Committee for applications may evolve criteria for shortlisting the candidates to be called for the interview as per the UGC Guidelines in consultation with the Vice Chancellor.
- e) DAV University will consider journals with SCI/ SCOPUS circulation index in science subjects and indexed journals in other streams.
- f) In case the number of applicants exceeds some limit the shortlisting will be done as per a criteria specified. Only the shortlisted candidates shall be invited for interview. The short-listed candidates shall be treated at equally at the time of the interview.

5. **The applications on prescribed format must reach before or on July 4, 2016. Incomplete applications or applications reaching after 5:00 pm on July 4, 2016 shall not be entertained.**
6. Separate applications along with Demand Drafts are required for each post.
7. Candidates need not to send complete photocopies of their publications at the time of application. They should send only the copy of the front page of reprints of each publication mentioned by them in the application.
