The following suggestions are given by the experts.

- Invite comments from Professors of other Universities on contents of syllabi.
- Board of studies members should be invited from industry also.
- The 25% weightage for Part A in the examination must include assignments, tutorial sheets, quiz, seminars, etc.
- Weightage to continuous assessment of Practical Examinations must be enhanced to 40% to 50%.
- Course codes should be odd for odd semesters and even for even semesters.
- Course codes for interdisciplinary subjects should be different from CSA code and must be identified by some other code, e.g., CS-ID.
