



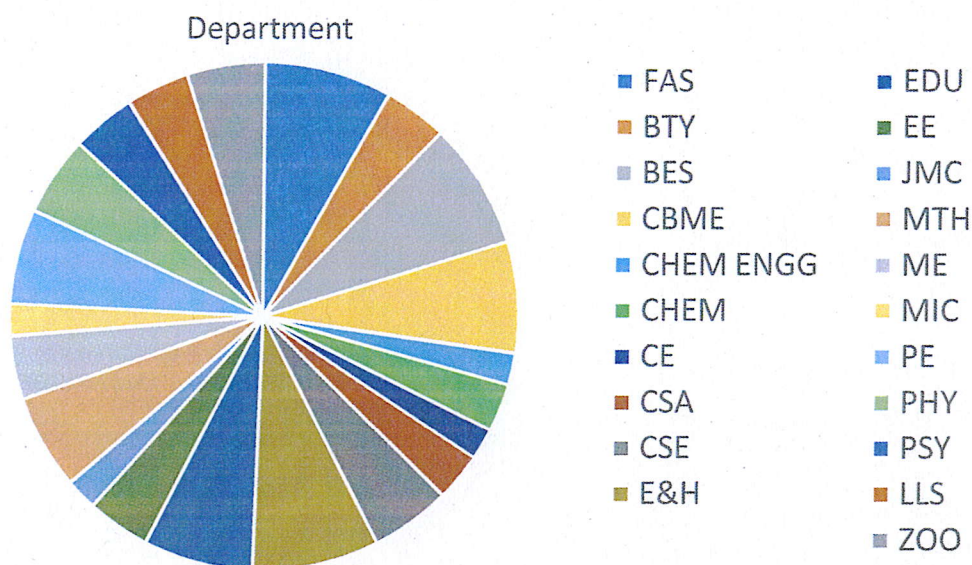

We have collected feedback from our faculties of different branches for the session 2021-22. Total 98 faculties of different departments participated in the feedback and responded to a variety of questions.



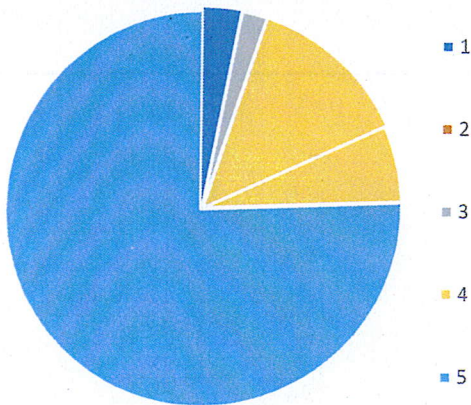
The faculties were encouraged to participate in the process in an unbiased manner and respond to questions in accordance to their experience.
